Occupational Health Safety Assessment System (OHSAS) 18001 is an international standard for occupational health and safety management systems. In 2018 the new standard for occupation health and safety ISO 45001 was released.

ISO 45001:2018/ OHSAS 18001:2007 is a combined management system for the working environment and safety similar to what is used for quality assurance within a company.

It is also important where effective energy management is a criteria for being approved as a supplier.

ISO 22000:2018 is the food safety management system standard where an organization demonstrates its ability to control food safety hazards to ensure that food is safe for human consumption.

ISO 22000:2018 is applicable to all types of organizations, regardless of size, which is involved in any aspect of the food chain.
